PART I : SECTION (I) — GENERAL

Government Notifications

NATIONAL POLICE COMMISSION

THE delegation of Powers by The National Police Commission in terms of Article 155J of the 21st Amendment to the Constitution of the Democratic Socialist Republic of Sri Lanka.

1. By virtue of the Powers vested in the National Police Commission under and in terms of Article 155G of the Constitution of the Democratic Socialist Republic of Sri Lanka, from among the Officers employed in the Sri Lanka Police Service, in respect of the Officers specified in column II of the schedule hereto, the Powers specifically mentioned in Column III of the said schedule are hereby delegated to the Officers specified in Column I of the schedule hereto by the National Police Commission.

Provided that, in the event of any question arising in relation to any delegation of Powers or as to the exercise of Power so delegated, the decision of the National Police Commission shall be final and conclusive.

Provided further that, if any Police Officer specified in Column I, is a complainant or a witness or a potential witness at any disciplinary inquiry against a Police Officer specified in Column II, the Powers of appointment, promotion, transfer, disciplinary control and dismissal, as are specified in Column III of the schedule hereto, shall be exercised as if no delegation in respect thereof had been made to the relevant Officer specified in Column I.

2. The National Police Commission hereby specify that in the exercise of the Powers hereby delegated by the National Police Commission to the Inspector General of Police and to any other Police Officers, to whom such Powers are



hereby delegated, shall at all times comply with the Procedural Rules in force at the relevant time, in respect of appointment, promotion, transfer, disciplinary control and dismissal of Police Officers, made by the National Police Commission, in terms of Article 155G of the Constitution and also with such Conditions and any Rules, Regulations and other Procedures which the Commission from time to time formulate.

Provided that, until such time the National Police Commission promulgates Rules, Regulations or Procedures under and in terms of Article 155G of the Constitution, in respect of matters provided for in the said Rules, Regulations or Procedures, all other Rules, Regulations and Procedures relating to the Police Service as were in force on the date of the coming in to operation of the 21st Amendment to the Constitution, shall *mutatis mutandis* continue to be in force and apply to the Police Service as if they have been made or provided by the National Police Commission.

3. The National Police Commission shall exercise directly, the powers vested in it under Article 155G of the Constitution, in respect of the Police Officers not specifically mentioned in Column II of the Schedule hereto.

4. It is hereby declared by the National Police Commission that the *Extraordinary Gazette* Notification bearing No. 2202/24 dated 20.11.2020 and *Extraordinary Gazette* Notification bearing No. 2216/12 dated 23.02.2021 together with any other *Extraordinary Gazette Notifications* relating to the delegation of powers issued so far in respect of Police Officers shall be hereby rescinded. The above rescission however shall be without prejudice to any action already taken under the delegation of powers made by the Public Service Commission under the aforesaid *Extraordinary Gazette* Notification bearing No. 2202/24 dated 20.11.2020 and *Extraordinary Gazette* Notification bearing No. 2216/12 dated 23.02.2021.

5. It is hereby declared that the delegation of powers specified herein shall be in operation with effect from 24.07.2023

6. In the event of any inconsistency between Sinhala, Tamil, and English texts, the Sinhala text shall prevail.
