Applications are invited from qualified citizens of Sri Lanka for the post of Legal Officer on the National police commission.

#### No. of Vacancies - 01

#### 01. Method of Recruitment

Candidate securing the highest marks based on the results of the Interview conducted by the Interview Board appointed by the National Police Commission among the applicants who have fulfilled the qualifications mentioned in this advertisement will be recruited. The interview will be conducted according to the procedure of giving marks (as mentioned under 06) approved by the National Police Commission.

#### 02. Required Qualifications

- I. Educational Qualifications / Professional Qualifications Should have obtained a degree in Law from a university recognized by the University Grants Commission / should have taken oaths as an Attorney of the Supreme Court. (Higher Qualifications in law will be considered as additional qualifications.)
- II. Experience Should have active professional experience of not less than three (03) years after taking oaths as an Attorney of the Supreme Court.
- III. Physical Qualifications
  Every candidate should be physically and mentally fit to serve in any part of Sri Lanka as per the requirement of the National Police Commission and to discharge the duties entrusted to the post.

#### IV. Others

- Should be a citizen of Sri Lanka
- Applicants should bear an excellent Character
- Should have fulfilled in every aspect of all the qualifications required for recruitment to the post as at the closing date of applications.

#### 03. Conditions for deployment in service and Service Conditions.

- I. This post is permanent and pensionable. Should abide by the policy decisions taken by the government regarding pensions.
- II. Appointment is subject to a probation period of three (03) years. Legal Officer should pass the 1<sup>st</sup> efficiency bar examination as mentioned in the recruitment procedure within three years of recruitment to Grade III.

- III. As per the Public Administration Circular No.01/2014 dated 21.01.2014, should obtain proficiency in the other official language in addition to the language of joining the service within 05 years of recruitment to the post and the officers who join the service in a language other than official languages should obtain the proficiency in the official language within the probation period.
- IV. This appointment is subject to the work procedure rules and regulations of the Public Services Commission, Establishment code of the Government of the Democratic Socialist Republic of Sri Lanka, Public Finance Regulations and other orders and instructions imposed by National Police Commission from time to time.
- V. This is an appointment of the National Police Commission.
